AN ORDINANCE DECLARING A PART OF 2.89 HA OF THE MUNICIPAL OWNED LAND OF THE MUNICIPALITY OF MAGALLANES SITUATED IN SITIO KAYHABOL, BARANGAY RAMIREZ AS AN OFFICIAL ECO PARK OF THE MUNICIPALITY

SECTION 1. Short Title - This Ordinance shall be known as the "Magallanes Eco-park Ordinance 2017"

SECTION 2. Statement of Purpose – In the pursuit of environmental preservation, this ordinance aims to establish a place in the municipality where the environmental activities and project can be properly conducted.

SECTION 3. Location, Area and Description of the Magallanes Eco-Park - There shall be an established Eco-park in the Municipality at Sitio Kayhabol, Barangay Ramirez, with an area of 0.8 ha or 8, 000 sq meters;

SECTION 4. Allowable Activities.

- a. Waste Utilization, composting, segregation, sorting;
- b. Storage for waste collected; and
- c. Other environment related activities that will be permitted by Office of the Mayor through the MENRO

SECTION 5. Improvement/Development. - All improvement/development on the Municipal Eco-park must be with MENRO, the Municipal Government of Magallanes and in accordance with the approved site development plan.

SECTION 6. Appropriation – For the first five (5) years of operation, the appropriation in the amount of One Million Pesos (P1, 000, 000.00) per year, for the establishment and maintenance of the Municipal Eco-park, shall be taken from the 20% Development Fund. The budget for subsequent years, which shall not be less than the amount of the prior years' appropriation, shall be included in the annual budget of the MENRO.

SECTION 7. Repealing Clause. All previous ordinance, executive orders, rules and regulations or parts thereof which are inconsistent with this ordinance are hereby repealed and/or modified accordingly.

SECTION 8. Separability Clause. If, for any reason or reasons, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby, shall continue to be in full force and in effect.

SECTION 9. – Effectivity. – This Ordinance shall take effect upon its approval.
