A RESOLUTION RESPECTFULLY REQUESTING HON. JESUS CRISPIN REMULLA, PROVINCIAL GOVERNOR OF CAVITE THRU ENGR. GEORGE B. FOJAS, PROVINCIAL ENGINEER TO LEND ONE (1) UNIT OF GRADER TO THE MUNICIPAL GOVERNMENT OF MAGALLANES, CAVITE TO BE USED FOR THE IMPROVEMENT OF VARIOUS BARANGAY ROADS IN THE MUNICIPALITY

WHEREAS, the Municipality of Magallanes is the farthest town in the province of Magallanes, whereby the main source of its residence is farming;

WHEREAS, majority of its residents most especially the farmers and commuters from the most remote barangays, request for the improvement of their barangay roads so that their agricultural products be easily transported from their respective areas to the public market and for the convenience of the commuters;

WHEREAS, because of the insistent request of the towns people of Magallanes and in the interest of public welfare, this Honorable August Body, deemed it necessary to request equipment that can be used for the barangay road improvement;

NOW THEREFORE, in a unanimous decision of all members present, it was

RESOLVED, as it is hereby resolved, to RESPECTFULLY REQUEST HON. JESUS CRISPIN REMULLA, PROVINCIAL GOVERNOR OF CAVITE THRU ENGR. GEORGE B. FOJAS, PROVINCIAL ENGINEER TO LEND ONE (1) UNIT OF GRADER TO THE MUNICIPAL GOVERNMENT OF MAGALLANES, CAVITE TO BE USED FOR THE IMPROVEMENT OF VARIOUS BARANGAY ROADS IN THE MUNICIPALITY
