DIOKNO FOR THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS IN THE MUNICIPALITY OF MAGALLANES, CAVITE

WHEREAS, it is the policy of the state to free the people from poverty by providing adequate social services, promoting full employment, raising the standard of living and improve quality of life;

WHEREAS, in order to support this state policy, R. A. 9994 known as Expanded Senior Citizens Act of 2010 was passed with the objective to improve the total wellbeing of the elderly or senior citizens;

WHEREAS, R.A. 9994 stipulates the monthly pension of qualified indigent senior citizens in the amount of Five Hundred Pesos (P500.00) as government assistance to augment their daily subsistence and other medical needs;

WHEREAS, to execute and enforce the official implementation of The Social Pension Program for the said qualified Indigent Senior Citizens, it is a requirement that the SB shall adopt a resolution authorizing the Municipal Mayor to enter into a MOA with the DSWD;
