A RESOLUTION REQUESTING OFFICE OF THE LOCAL CHIEF EXECUTIVE TO PURCHASE A NOISE MEASURING DEVICE FOR THE PROPER AND EFFECTIVE IMPLEMENTATION OF THE MUNICIPAL ORDINANCE NO. 010 S. 2016 - "AN ORDINANCE PENALIZING ALL PUBLIC AND PRIVATE VEHICLES INCLUDING MOTORCYCLES/ MOTORBIKES WITHIN THE MUNICIPALITY OF MAGALLANES, CAVITE FOR USING MODIFIED MUFFLERS WHICH CREATES IRRITATING, EXCESSIVE SOUND WHICH RESULTS TO NOISE POLLUTION"

WHEREAS, due to the number of residents that are complaining of the noise coming from vehicles whose mufflers were modified and create excessive and irritating sound, Municipal Ordinance No. 010 s. 2016 was approved by the Municipality Government of Magallanes;

WHEREAS, to ensure the full implementation of the said ordinance, the implementing body shall be equipped with a decibel meter to effectively gauge the intensity of loudness of a motor vehicle;

WHEREAS, this august body found the proposed purchase of decibel meter to be timely and necessary;

NOW THEREFORE, in a unanimous decision of the members present, be it,


