A RESOLUTION AUTHORIZING THE LGU, MAGALLANES, CAVITE TO SUBSCRIBE TO LAND BANK OF THE PHILIPPINES (LBP) ONLINE TAX SYSTEM KNOWN AS "e-Tax Payment System" AND DESIGNATING AUTHORIZED SIGNATORIES TO ENROLL AND USE/ACCESS TO LBP's e-Tax Payment System"

WHEREAS, submitted to the Honorable Members of the Sangguniang Bayan for review and consideration is a letter from Hon. Jasmin Angelli M. Bautista, Municipal Mayor, requesting for a passage of a resolution authorizing the LGU of Magallanes to subscribe to the Land Bank of the Philippines (LBP's) Online Tax Payment System known as "e-Tax Payment System";

WHEREAS, the subscription to internal payment facility shall not only serve time and effort not to mention the risk in going to Land Bank of the Philippines;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED by the Sangguniang Bayan in session assembled to authorize and approve the following:

1. Subscribe to the Land Bank of the Philippines (LBP's) Online Tax Payment System known as "e-Tax Payment System";
2. Authorize **HON. JASMIN ANGELLI M. BAUTISTA** in behalf of the Municipality of Magallanes to enroll in the LANDBANK's "e-Tax Payment System" and execute/sign all documents necessary for the subscription;
3. Designate and authorize **MS. EUGENIA M. JULIAN**, Municipal Accountant, to act as "maker" and **HON. JASMIN ANGELLI M. BAUTISTA** or **MS. ADELINA M. MARTAL**, Municipal Treasurer as "authorizer" for the LGU's access to LBP's Online Tax Payment System known as "e-Tax Payment System; and


